6. So far as regards the Administrator General, the High Court shall be deemed to be a Court of competent jurisdiction for the purpose of granting probate or letters of administration under any law for the time being in force wheresoever the estate to be administered is situate.

7. Any letters of administration which are granted by the High Court shall be granted to the Administrator General unless they are granted to the next-of-kin of the deceased.

8. The Administrator General shall be deemed by all the Courts to have a right to letters of administration other than letters *pendente lite* in preference to that of—

(4) Nothing in this section shall prejudice the right of any creditor or other claimant to follow the assets or any part thereof in the hands of the persons who may have received the same respectively.

(5) In computing the period of limitation for any suit, appeal or application under the provisions of any law for the time being in force. the period between the date of submission of the claim of a creditor to the Administrator General and the date of the final decision of the Administrator General on such claim shall be excluded.

27. from Administrator General. 28. (1) The High Court may, on application made to it, give to the Administrator General any general or special directions as to any estate in his charge or in regard to the administration of any such estate.

(2) Applications under sub-section (1) may be made by the Administrator General or any person interested in the assets or in the due administration thereof.

29. (1) The Administrator General shall not be required by any Court to enter into any administration-bond, or to give other security to the Court, on the grant of any letters of administration to him by that name.

Manner in which petitions to be verified by Administrator General and his Deputy.

Entry of Administrator General not to constitute notice of a trust. (2) Neither the Administrator General nor the Deputy Administrator General shall be required to verify, otherwise than by his signature, any petition presented by him under the provisions of this Act. and, if the facts stated in any such petition are not within the Administrator General's own personal knowledge, the petition may be subscribed and verified by any person competent to make the verification.

(3) The entry of the Administrator General by that name in the books of a company shall not constitute notice of a trust, and a company shall not be entitled to object to enter the name of the Administrator General on its register by reason only that the Administrator General is a corporation, and in dealing with assets the fact that the person dealt with is the Administrator General shall not of itself constitute notice of a trust.

Power to examine on oath. 30. The Administrator General may, whenever he desires, for the purposes of this Act, to satisfy himself regarding any question of fact, examine upon oath (which he is hereby authorized to administer) any person who is willing to be so examined by him regarding such question.

(e) Grant of Certificates.

In what case Administrator General may grant certificate. 31. Whenever any person has died leaving assets in the Union of Burma, and the Administrator General is satisfied that such assets, excluding any sum of money deposited in a Government Savings Bank, or in any provident fund to which the provisions of the Provident Funds Act apply, did not at the date of death exceed in the whole two thousand rupees in value, he may, after the lapse of one month from the death if he thinks fit, or before the lapse of the said month if he is requested so to do by writing under the hand of the executor or the widow or other person entitled to administer the estate of the deceased, grant to any person claiming otherwise than as a creditor to be interested in such assets, or in the due administration thereof, a certificate under his hand entitling the claimant to receive the assets therein mentioned left by the deceased in the Union of Burma to a value not exceeding in the whole two thousand rupees :

Provided that no certificate shall be granted under this section-

- (i) where probate of the deceased's will or letters of administration of his estate has or have been granted, or
- (ii) in respect of any sum of money deposited in a Government Savings Bank or in any provident fund to which the provisions of the Provident Funds Act apply.

32. If, in cases falling within section 31, no person claiming to be Grant of interested otherwise than as a creditor in such assets or in the due administration certificate to creditors thereof obtains, within three months of the death of the deceased, a certificate and power from the Administrator General under the same section, or probate of a will or to take charge of letters of administration of the estate of the deceased, and such deceased was certain not an exempted person, or was an exempted person who has left assets within estates. the ordinary original civil jurisdiction of the High Court, or within any area notified by the President of the Union in this behalf in the Gazette, the Administrator General may administer the estate without letters of administration, in the same manner as if such letters had been granted to him ; and if he neglects or refuses to administer such estate, he shall, upon the application of a creditor, grant a certificate to him in the same manner as if he were interested in such assets otherwise than as a creditor, and such certificate shall have the same effect as a certificate granted under the provisions of section 31, and shall be subject to all the provisions of this Act which are applicable to such certificate :

Provided that the Administrator General may, before granting such certificate, if he thinks fit, require the creditor to give reasonable security for the due administration of the estate of the deceased.

Revocation of certificate.

35. The Administrator General may revoke a certificate granted under the provisions of section 31 or section 32 on any of the following grounds, namely :---

- (i) that the certificate was obtained by fraud or misrepresentation made to him.
- (ii) that the certificate was obtained by means of an untrue allegation of a fact essential in law to justify the grant though such allegation was made in ignorance or inadvertently.

Surrender of revoked certificate. 36. (1) When a certificate is revoked in accordance with the provisions of section 35, the holder thereof shall, on the requisition of the Administrator General, deliver it up to the Administrator General, but shall not be entitled to the refund of any fee paid thereon.

(2) If such person wilfully and without reasonable cause omits to deliver up the certificate he shall be punishable with imprisonment which may extend to three months, or with fine which may extend to one thousand rupees, or with both.

Transfer of certain assets from the Union of Burma to executor or administrator in country of domicile for distribution.

37. The Administrator General shall not be bound to take out letters of administration of the estate of any deceased person on account of the assets in respect of which he grants any certificate, under section 31 or section 32, but he may do so if he revokes such certificate under section 35 or ascertains that the value of the estate exceeded two thousand rupees.

38. Where a person not having his domicile in the Union of Burma has died leaving assets in the Union of Burma and in the country in which he had his domicile at the time of his death, and proceedings for the administration of his estate with respect to assets in the Union of Burma have been taken under section 31 or section 32, and there has been a grant of administration in the country of domicile with respect to the assets in that country, the holder of the certificate granted under section 31 or section 32, or the Administrator General, as the case may be, after having given the prescribed notice for creditors and others to send in to him their claims against the estate of the deceased, and after having discharged, at the expiration of the time therein named, such lawful claims as he has notice of, may, instead of himself distributing any surplus or residue of the deceased's property to persons residing out of the Union of Burma who are entitled thereto, transfer, with the consent of the executor or administrator, as the case may be, in the country of domicile, the surplus or residue to him for distribution to those persons.

(f) Liability.

39. (1) The revenues of the Union of Burma shall be liable to make Liability of Government. good all sums required to discharge any liability which the Administrator General. if he were a private administrator, would be personally liable to discharge, except when the liability is one to which neither the Administrator General nor any of his officers has in any way contributed, or which neither he nor any of his officers could by the exercise of reasonable diligence have averted, and in either of those cases the Administrator General shall not, nor shall the revenues of the Union of Burma, be subject to any liability.

(2) *

40. (1) If any suit be brought by a creditor against the Administrator Creditor's General, such creditor shall be liable to pay the costs of the suit unless he suits against Adminisproves that not less than one month previous to the institution of the suit he trator had applied in writing to the Administrator General, stating the amount and General. other particulars of his claim, and had given such evidence in support thereof as, in the circumstances of the case, the Administrator General was reasonably entitled to require.

(2) If any such suit is decreed in favour of the creditor, he shall, nevertheless, unless he is a secured creditor, be only entitled to payment out of the assets of the deceased equally and rateably with the other creditors.

41. Nothing in section 80 of the Code of Civil Procedure shall apply to Notice of suit no any suit against the Administrator General in which no relief is claimed required in certain against him personally. cases.

PART IV.

FEES.

42. (1) There shall be charged in respect of the duties of the Admini- Fees. strator General such fees, whether by way of percentage or otherwise, as may be prescribed by the President of the Union :

Provided that, in respect of the duties of the Administrator General under the Regimental Debts Act, 1893, the fees prescribed in this section shall be determined in accordance with the provisions of that Act.

(2) The fees under this section may be at different rates for different estates or classes of estates or for different duties, and shall, so far as may be, be arranged so as to produce an amount sufficient to discharge the salaries and all other expenses incidental to the working of this Act (including such sum as the President of the Union may determine to be required to insure the revenues of the Union of Burma against loss under this Act).

43. (1) Any expenses which might be retained or paid out of any estate Disposal of in the charge of the Administrator General, if he were a private administrator fees. of such estate, shall be so retained or paid, and the fees prescribed under

section 42 shall be retained or paid in like manner as and in addition to such expenses.

(2) The Administrator General shall transfer and pay to such authority, in such manner and at such time as the President of the Union may prescribe, all fees received by him under this Act, and the same shall be carried to the account and credit of the Government.

PART V.

AUDIT OF THE ADMINISTRATOR GENERAL'S ACCOUNTS.

Audit of the Administrator-General's accounts. 44. The accounts of the Administrator-General shal! be audited at least once annually, and at any other time if the President of the Union so direct, by the prescribed person and in the prescribed manner.

Auditors to examine accounts and report to President.

45. The auditors shall examine the accounts and forward to the President of the Union a statement thereof in the prescribed form, together with a report thereon and a certificate signed by them showing,

- 1 (a) whether the accounts have been audited in the prescribed manner,
- ² (aa) whether, so far as can be ascertained by such audit, the accounts contained a full and true account of everything which ought to be inserted therein.
 - (b) whether the books which by any rules made under this Act are directed to be kept by the Administrator General have been duly and regularly kept, and
 - (c) whether the assets and securities have been duly kept and invested and deposited in the manner prescribed by this Act, or by any rules made thereunder,

or (as the case may be) that such accounts are deficient, or that the Administrator General has failed to comply with this Act or the rules made thereunder, in such respects as may be specified in such certificate.

46. (1) Every auditor shall have the powers of a civil Court under the Code of Civil Procedure,

auditors to summon and examine: witnesses, and to call for documents.

Power of

- (a) to summon any person whose presence he thinks necessary to attend him from time to time : and
- (b) to examine any person on oath to be by him administered; and
- (c) to issue a commission for the examination on interrogatories or otherwise of any persons; and
- (d) to summon any person to produce any document or thing the production of which appears to be necessary for the purpose of such audit or examination.

(2) Any person who when summoned refuses, or without reasonable cause neglects, to attend or to produce any document or thing, or attends and refuses to be sworn, or to be examined, shall be deemed to have committed an offence within the meaning of, and punishable under, section 188 of the Penal Code, and the auditor shall report every case of such refusal or neglect to the President of the Union.

47. The costs of and incidental to such audit and examination shall be Costs of determined in accordance with rules made by the President of the Union. and audit, etc. shall be defrayed in the prescribed manner.

PART VI.

MISCELLANEOUS.

48. The Administrator General may, in addition to and not in deroga. General tion of, any other powers of expenditure lawfully exercisable by him, incur administraexpenditure-

tion.

- (a) on such acts as may be necessary for the proper care and management of any property belonging to any estate in his charge, and
- (b) with the sanction of the High Court on such religious, charitable and other objects, and on such improvements as may be reasonable and proper in the case of such property.

49. Any person interested in the administration of any estate which is in Power of the charge of the Administrator General shall, subject to such conditions and person beneficially restrictions as may be prescribed, be entitled at all reasonable times to inspect interested to the accounts relating to such estate and the reports and certificates of the inspect Adauditor, and, on payment of the prescribed fee, to copies thereof and extracts General's therefrom.

accounts, etc., and take copics.

50. (1) The President of the Union shall make rules for carrying into Power to make rules. effect the objects of this Act and for regulating the proceedings of the Administrator General.

(2) In particular, and without prejudice to the generality of the foregoing power, such rules may provide for--

- (a) the accounts to be kept by the Administrator General and the audit and inspection thereof ;
- (b) the safe custody, deposit and investment of assets and securities which come into the hands of the Administrator General;
- (c) the remittance of sums of money in the hands of the Administrator General in cases in which such remittances are required ;

- (d) subject to the provisions of this Act, the fees to be paid under this Act, and the collection and accounting for any such fees;
- (e) the statements, schedules and other documents to be submitted to the President of the Union or to any other authority by the Administrator General and the publication of such statements, schedules or other documents;
- (f) the realization of the cost of preparing any such statements, schedules or other such documents;
- (g) the manner in which and the person by whom the costs of and incidental to any audit under the provisions of this Act are to be determined and defrayed;
- (h) the manner in which summonses issued under the provisions of section 46 are to be served, and the payment of the expenses of any persons summoned or examined under the provisions of this Act and of any expenditure incidental to such examination; and
- (i) any matter in this Act directed to be prescribed.

(3) All rules made under this Act shall be published in the Gazette and, on such publication, shall have effect as if enacted in this Act.

False evidence. 51. Whoever, during any examination authorized by this Act. makes upon oath a statement which is false, and which he either knows or believes to be false or does not believe to be true, shall be deemed to have intentionally given false evidence in a stage of a judicial proceeding.

Assets unclaimed for twelve years to be transferred to Government.

52. All assets in the charge of the Administrator General which have been in his custody for a period of twelve years or upwards without any application for payment thereof having been made and granted by him shall be transferred, in the prescribed manner, to the account and credit of the Government:

Provided that this section shall not authorize the transfer of any such assets as aforesaid if any suit or proceeding is pending in respect thereof in any Court.

Mode of proceeding by claimant to recover principal money so transferred.

53. (1) If any claim is hereafter made to any part of the assets transferred to the account and credit of the Government under the provisions of this Act and if such claim is established to the satisfaction of the prescribed authority, the Government shall pay to the claimant the amount of the principal so transferred to its account and credit or so much thereof as appears to be due to the claimant.

(2) If the claim is not established to the satisfaction of the prescribed authority, the claimant may, without prejudice to his right to take any other proceedings for the recovery of such assets, apply by petition to the High Court against the Government, and such Court, after taking such evidence as it thinks fit, shall make such order in regard to the payment of the whole or any part of the said principal sum as it thinks fit, and such order shall be binding on all parties to the proceeding :

Provided that nothing in this section affects any option afforded to a claimant [by any other law in force].1

(3) The Court may further direct by whom the whole or any part of the costs of each party shall be paid.

54. (1) Whenever any person, other than an exempted person, dies District leaving assets within the limits of the jurisdiction of a District Judge, the Gertain cases District Judge shall report the circumstance without delay to the Administrator to take General, stating the following particulars so far as they may be known to charge of property of him :--

deceased persons, and to report to

- (a) the amount and nature of the assets,
- (b) whether or not the deceased left a will and, if so, in whose Administra-tor General. custody it is,
- (c) the names and addresses of the surviving next-of-kin of the deceased.

and, on the lapse of one month from the date of the death,

(d) whether or not any one has applied for probate of the will of the deceased or letters of administration of his estate.

(2) The District Judge shall retain the assets under his charge. or appoint an officer under the provisions of section 269 of the Succession Act to take and keep possession of the same, until the Administrator General has obtained letters of administration, or until some other person has obtained probate or such letters or a certificate from the Administrator General under the provisions of this Act, when the assets shall be delivered over to the holder of such probate, letters of administration or certificate :

Provided that the District Judge may, if he thinks fit, sell any assets which are subject to speedy and natural decay, or which for any other sufficient cause he thinks should be sold, and he shall thereupon credit the proceeds of such sale to the estate.

(3) The District Judge may cause to be paid out of any assets of which he or such officer has charge, or out of the proceeds of such assets or of any part thereof, such sums as may appear to him to be necessary for all or any of the following purposes. namely :-

- (a) the payment of the expenses of the funeral of the deceased and of obtaining probate of his will or letters of administration of his estate or a certificate under this Act.
- (b) the payment of wages due for services rendered to the deceased within three months next preceding his death by any labourer. artizan or domestic servant.
- (c) the relief of the immediate necessities of the family of the deceased. and

(d) such acts as may be necessary for the proper care and management of the assets left by the deceased,

and nothing in the Succession Act or in any other law for the time being in force with respect to rights of priority of creditors of deceased persons shall be held to affect the validity of any payment so caused to be made.

55. (1) Nothing contained in the Succession Act or the Burma Companies Act shall be taken to supersede or affect the rights, duties and privileges of the Administrator General.

(2) Nothing contained in the Succession Act or in this Act shall be deemed to affect, or to have affected, any law for the time being in force relating to the moveable property under two hundred rupees in value of provisions of persons dying intestate in the town of Rangoon, which shall be or has been taken charge of by the police for the purpose of safe custody.

> 56. Any order made under this Act by any Court shall have the same effect as a decree.

> 57. Notwithstanding anything in this Act, or in any other law for the time being in force, the President of the Union may, by general or special order, direct that, where a subject of a foreign State dies in the Union of Burma, and it appears that there is no one in the Union of Burma other than the Administrator General entitled to apply to a Court of competent jurisdiction for letters of administration of the estate of the deceased, letters of administration shall, on the application to such Court of any Consular Officer of such foreign State, be granted to such Consular Officer on such terms and conditions as the Court may, subject to any rules made in this behalf by the President of the Union by notification in the Gazette, think fit to impose.

THE LEGAL REPRESENTATIVES SUITS ACT.

[INDIA ACT XII, 1855.] (27th March, 1855.)

Preamble.

Whereas it is expedient to enable executors, administrators or representatives in certain cases to sue and be sued in respect of certain wrongs which. according to the present law, do not survive to or against such executors, administrators or representatives; It is enacted as follows :-
